4. The Management of Investment Manager is also responsible for identifying the assets offered as security for the debt securities in accordance with Debenture Trust Deed dated 10 June 2023.

Practitioner's Responsibility

5. It is our responsibility to provide reasonable assurance whether the amounts mentioned in the Statement have been accurately extracted from the books of account and other relevant records which we have verified as produced before us.
6. We conducted our examination of the Statement in accordance with the Guidance Note on Reports or Certificates for Special Purposes issued by the Institute of Chartered Accountants of India. The Guidance Note requires that we comply with the ethical requirements of the Code of Ethics issued by the Institute of Chartered Accountants of India.

7. We have complied with the relevant applicable requirements of the Standard on Quality Control (SQC) 1, Quality Control for Firms that Perform Audits and Reviews of Historical Financial Information, and Other Assurance and Related Services Engagements.

Opinion

8. Based on our examination, as above, and the information and explanations given to us, we are of the opinion that:
- i. the amounts and relevant details given in Column "A" to "L" as mentioned in the Statement have been accurately extracted from the books of account and other relevant records maintained by the Trust.
 - ii. the computation of pari-passu security cover ratio is arithmetically correct.

The certificate is addressed to and provided to the management of the Investment Manager solely for the purpose of submission to the Debenture Trustee/Stock Exchanges and should not be used by any other person or for any other purpose. 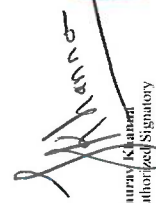
